PEC is proud to be guided by the seven cooperative principles:

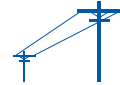

# PROVIDING AFFORDABLE POWER: SEE HOW OUR RATES COMPARE

| Average Cost Comparison       | 1,000 kWh | 1,250 kWh | 1,500 kWh | 2,000 kWh |

| PEC residential average       | \$134.00  | \$160.00  | \$186.00  | \$238.00  |

## RECOGNITION & ACHIEVEMENTS

We are committed to being a top electric distribution cooperative by delivering exceptional customer service and reliability, maintaining a strong financial position, and investing in our employees for the benefit of our entire membership.

- Fitch Ratings affirmed PEC's AA- rating in December 2024.
- PEC reached a major milestone, surpassing 420,000 meters in 2024. Over the past decade, PEC has experienced historic growth across its service territory with many areas ranking among the fastest growing in the U.S.
- The Cooperative took operational control of its transmission assets last spring, allowing PEC increased control over its assets, maintenance, and day-to-day management.
- At the 2024 International Lineman's Rodeo, PEC won the top overall apprentice spot for the third consecutive year, bringing home a total of six trophies.
- PEC was recognized as a 2024 National Top Workplaces Industry winner for Energy & Utilities and ranked third in the nation among employers with more than 500 employees.



## COMMUNITY ENGAGEMENT

One of our core cooperative principles – Concern for Community – guides our mission to help make a difference in the communities we serve. It's why we strive to make the place we love to live even better.



- PEC's Power of Change Program allows members to voluntarily round up their electric bills to the nearest dollar for charity. Those member donations fund community grants for area nonprofits. Since launching, more than 36,000 members have contributed more than \$1 million.
- We are proud members of 35 area chambers of commerce.
- We inspire the next generation of PEC members by providing students with educational and scholarship programs. Since beginning the program 26 years ago, PEC has provided more than \$1.5 million in scholarships to high school seniors and adults seeking to further their educations.

### TOP 100 CO-OP

In 2024, PEC was named among the top 100 cooperatives in the country as part of National Cooperative Bank's annual Co-op Top 100 list. PEC is ranked no. 89 based on revenue.
